

**DANGER****HAZARD STATEMENTS**

Causes severe skin burns and eye damage

PRECAUTIONARY STATEMENTS

Prevention: Do not breathe dust/fume/gas/mist/vapors/spray. Wash face, hands and any exposed skin thoroughly after handling. Wear protective gloves/protective clothing/eye protection/face protection.

General Advice: Immediately call a POISON CONTROL CENTER or doctor/physician. **Eyes:** IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do so. Continue rinsing. Immediately call a POISON CONTROL CENTER or doctor/physician. **Skin:** IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water/shower. Wash contaminated clothing before reuse. **Inhalation:** IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. **Ingestion:** IF SWALLOWED: Rinse mouth. DO NOT induce vomiting. Immediately drink large quantities of raw egg, milk or milk of magnesia, then drink large quantities of water. Follow with vegetable, olive or mineral oil. **Fire:** None. **Spills and Leaks:** None. **Storage:** Store locked up. **Disposal:** Dispose of contents/container to an approved waste disposal plant.

To clean ice machine, add 8 oz. of Noble Chemical ARCTIC Ready to Use Ice Machine Cleaner per 1 gallon of water and let circulate for 10 minutes. Brush on all surfaces as needed. Fill reservoir and rinse all surfaces with fresh water. Allow fresh water to circulate for 2 minutes to flush. To sanitize ice machine, use Noble Chemical QuikSan Ice Machine Sanitizer as directed.
