A. Product Description

Labeling: Tapioca Pudding, Artificially Flavored

An aseptically, canned, shelf-stable ready-to-serve pudding.

B. General Requirements

1. Pudding shall be packed in accordance with current good manufacturing practices and shall comply with the FDA Standards for Thermally Processed Low-Acid Foods Packaged in Hermetically Sealed Containers, Part 113 of the Code of Federal Regulations, Title 21 and to all applicable USDA, State and local regulations.

C. Ingredients

SKIM MILK, WATER, SUGAR, TAPIOCA, MODIFIED FOOD STARCH (CORN), VEGETABLE OIL (CONTAINS ONE OR MORE OF THE FOLLOWING: CANOLA OIL, PALM OIL, SUNFLOWER OIL, SOYBEAN OIL), CONTAINS 2% OR LESS OF: SALT, NATURAL AND ARTIFICIAL FLAVORS, SODIUM STEAROYL LACTYLATE, COLOR ADDED, SODIUM PHOSPHATE, YELLOW 5, YELLOW 6 AND SOY LECITHIN.
