STORAGE, HANDLING, & BEST BY DATE

Corn Syrup is best if used within 1 year from date of manufacturer. The recommended bulk storage temperature is 120°-125° F and ambient temperature for packaged product. The product may darken overtime depending upon storage temperature. Syrup stored at recommended temperatures or below should be evaluated for color after best by date.

Corn Syrup is derived from corn, which may have been genetically modified. Based on information provided by our suppliers, there is no remaining DNA in the product.
