Sugar, Dextrose, Corn Syrup, Gum Base, Gum Arabic, Tapioca Dextrin, Confectioners Glaze, Carnuba Wax, Artificial Flavors, Artificial Colors (FD&C Blue 1, Yellow 5, Red 40, Blue 2 Lake, Blue 1 Lake), Corn Starch, BHT (to maintain freshness).
Milk and Soy may be present.
Contains a bioengineered food ingredient.
