Storage: Store in an ambient controlled climate (76°F +/- 5°F) in a cool, dry place. Keep product from exposure to moisture and heat, extreme temperatures, humidity, or cool and winter temperatures.

Shipping: Ship in ambient temperatures under conditions that will prevent damage. Closed dry van trucks free from conditions that could result in contamination of material. Less than truckload (LTL) must not ship with product that may be harmful or detrimental in nature. Do not refrigerate. Do not double-stack pallets.
