GENERAL ALLERGEN STATEMENT:

- Careful selection of suppliers/manufacturers of ingredients: Our ingredients are the highest quality producers can provide to us. We require reliable information about any risks involving allergens in raw materials. See the chart below for details.
- Eliminating cross contamination risks: Incoming inspection is key to preventing unintentional sources of 2) allergens from entering the plant by shipping contamination. Our personnel carefully inspect trucks and packages to prevent unknown or unclean materials from entering the plant.
- Maintenance of a dedicated plant: We operate a dedicated facility which does not process any raw material containing common allergens. This virtually eliminates the risk of processing cross contamination in our operation.
