Description: Long grain brown rice which has gone through a steam-pressure process before milling. The process gelatinizes the starch in the grain and ensures a firmer, more separate rice when prepared. The rice is processed to remove only the outer husk, leaving the bran layer intact. The product is considered 100% whole grain. Uncooked, the grains are golden brown in color. When cooked, the product is light brown with a slightly nutty flavor. This rice is produced from a raw agricultural commodity and must be cooked prior to consumption. Refrigerate cooked leftovers promptly.
