Description: A Kosher and organic certified tofu made from non-GMO organic soybeans, water, magnesium chloride (nigari), and calcium sulfate. The soybeans are soaked, ground and cooked with water. After cooking, the soymilk is extracted from the pulp. Magnesium chloride (nigari) and calcium sulfate are added to the soymilk to coagulate the protein. The protein curd is then pressed, packaged, sealed, pasteurized and chilled. Nasoya Extra Firm Tofu is made in the USA.

Ingredient List: Water, Organic Soybeans, Less than 2% of Calcium Sulfate, Magnesium Chloride

Packaging: The tofu block is packaged in a polypropylene tray with a hermetically sealed top film consisting of polyester bonded to CPP.
