

## **ORDERING STEPS**

## **MOUNT OPTIONS** — REQUIRED TO BE PURCHASED FROM STORE TECHNOLOGY

There are 3 CTT mount options to choose from. Assess your store's layout to determine which mount is best for your operations. Ensure your store can support the desired mount.

#### **CTT Table Mount**


Mounted to the top of your cut table, this option allows you to take advantage of power and data cabling available from the floor or nearby power pole. (optional Advanced Dispatch attachment available)

#### **CTT Ceiling Mount**

Mounted to a pole from the ceiling, this option allows you to take advantage of power and data cabling available from the ceiling while allowing you to mount CTT above your cut table.

### **CTT Ready & Set Station Mount**

Mounted to a Ready & Set Station (available on CNA Marketplace), this option allows you to utilize tech storage found on the Ready & Set Station while providing a mounting location for CTT above your cut table.

With extension pole: The ceiling mount can extend from 81.5 inches to 87.5 inches in 2-inch increments. Without extension pole: The ceiling mount can be adjusted from 61.5 inches to 67.5 inches in 2-inch increments.

The bottom of the pole should be 40-46 inches from the finished floor when installed.
