- **2. Entrants and entries must fulfill all requirements to be eligible to win prize. Entries that are not complete or do not adhere to the Official Rules may be disqualified at the sole discretion of Sponsors. Entrant may only submit one entry. Entrant may not use multiple email addresses, identities, or devices in an attempt to circumvent this rule. If Entrant uses fraudulent methods or otherwise attempt to circumvent the rules, their entry may be disqualified at the sole discretion of Sponsors.
