



LightFry LIMITED WARRANTY

EATGOOD SWEDEN AB grants to the original purchaser of this LightFry Unit a limited warranty, as described herein (the "Warranty"), of one (1) year on parts and one (1) year on labor (the "Warranty Period"), which Warranty Period shall commence on the date the LightFry Unit was installed. The Warranty only covers repairs to correct any unit defects related to materials or workmanship that existed on the LightFry Unit at the time of purchase.

WARRANTY TERMS

This Warranty extends only to the original purchaser and is non-transferable. This Warranty only applies if the original purchaser registers the serial number of the LightFry Unit with EATGOOD SWEDEN AB, or its duly authorized representatives (collectively, "Warrantor"), within thirty (30) days from the date of installation. To register your LightFry Unit please visit www.LightfryUSA.com or mail your completed LightFry Warranty Registration Card to the name and address set forth on the Registration Card. To qualify for the Warranty, the LightFry Unit must be unaltered, properly installed and maintained in accordance with national and local codes and in accordance with the manufacturer's manual(s) and installation checklist(s). This Warranty may be voided, in whole or in part, as the sole discretion of Warrantor, if payment in full is not received within thirty (30) days of purchase. Warranty services are provided only if defects are made known to Warrantor within 14 days after they become known or recognizable by the original purchaser. All Warranty requests must be approved by Warrantor prior to any work being performed during the Warranty Period. This Warranty is subject to the Exclusions set forth below. This Warranty specifically excludes, and no Warranty will be given for, any LightFry Units installed in residential locations or "food trucks" or similar mobile food delivery systems.

EXCLUSIONS:

This Warranty Does Not Cover Any:

1. Damages resulting from accident, abuse, fire, flood, alteration, or acts of God. Tampering, altering, defacing, or removing the LightFry Unit serial number will serve to void this Warranty.
2. Damages resulting from improper use of the LightFry Unit or use of the LightFry Unit in a corrosive atmosphere.
3. Damages resulting from inadequacy or interruption of electrical service or improper voltage conditions, blown fuses, or other like damages.
4. Damages resulting from failure to properly and regularly clean, maintain, or service the LightFry Unit. Daily cleaning and periodic maintenance on the LightFry Unit is required, and failure to so clean and maintain the LightFry Unit, or failure to follow the LightFry Unit service plan, will void this Warranty. Use of not recommended cleaning detergent(s), or using dirty or corrosive water, will also void this Warranty.
5. Damages resulting from improper installation of the LightFry Unit, usage of the LightFry Unit in a manner that does not comply with the technical or safety requirements of the LightFry Unit, or poor handling of the LightFry Unit.
6. Damages resulting from repair attempts that are unprofessional, improper, or made by an unauthorized third party, including the original purchaser.
7. This Warranty only covers the LightFry Unit; no accessories are warranted or covered by this Warranty.
8. Wear and tear on any rubber or silicone gaskets, including but not limited to, the Main Door Gasket (Part No. 32066) and Basket Door Gasket (Part No. 31263).



1. Use of non-authorized original parts.

Should Warrantor, or its Warranty service provider, determine that the defect in question does not entitle the original purchaser to a Warranty claim, the costs of the inspection and work are to be borne by the customer making the Warranty claim. Warrantor assumes no liability for transportation costs or risks.

THE LIMITED WARRANTY SET FORTH HEREIN IS IN LIEU OF ALL OTHER WARRANTIES AND LIABILITIES, WHETHER IN CONTRACT OR IN NEGLIGENCE, EXPRESS OR IMPLIED, IN LAW OR IN FACT, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR USE, AND IN NO EVENT SHALL WARRANTOR BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO LOSS OF USE OF THE EQUIPMENT OR ASSOCIATED EQUIPMENT, LOST REVENUES OR PROFITS, COST OF SUBSTITUTE EQUIPMENT OR COST OF FUEL OR ELECTRICITY. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE.

Should any covered Warranty defects occur within the Warranty Period that are not excluded, Warrantor shall, at its own discretion, remedy such Warranty defects free for charge through repairs, replacement of defective parts, or replacement of the LightFry Unit. The performance of Warranty services does not result in the Warranty Period being restarted or extended. This Warranty does not entitle the original purchaser to free inspections or maintenance. Warrantor shall attempt, but cannot guarantee, to perform any Warranty work in a manner and at a time so as to minimize any interference, or disrupt the operations of the original purchaser. All Warranty work will be performed by a duly authorized equipment service agency chosen by Warrantor in Warrantor's sole and absolute discretion. Warrantor will make a good faith effort to have its duly authorized equipment service agency perform Warranty work at the location in which the LightFry Unit was installed, but in no event will Warrantor be required to incur travel time in excess of two hours or 50 miles. In the event Warrantor is required to incur travel time in excess of two hours or 50 miles to perform Warranty work, for any reason whatsoever, Purchaser will be responsible to have the LightFry Unit delivered to Warrantor to perform said Warranty work and/or pre-pay Warrantor for Warrantor's travel time.
