

**CAMBRO 2026 SPRING CLEAN SWEEPSTAKES**  
**OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN.  
A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Sponsor:** The Sponsors of the Cambro 2026 Spring Clean Sweepstakes (the “Sweepstakes”) are The WebstaurantStore, LLC (“WEB”), 40 Citation Lane, Lititz, PA 17543, and Cambro Manufacturing (“Cambro”), 5801 Skylab Road, Huntington Beach, CA 92647. The Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Meta Platforms. Meta Platforms is hereby completely released of all liability by each participant in the Sweepstakes. Any questions, comments or complaints regarding the Sweepstakes must be directed to Sponsor and not to Meta Platforms.
  
- 2. Eligibility:** The Sweepstakes is open only to legal residents of the United States of America who are at least 18 years old or age of majority in their state of residency, as of the date of entry (“Entrant(s)”), and who own or operate a commercial establishment or space (“Company”) that contains a delivery station or walk- in refrigerator or freezer. Resellers are not eligible to win. Employees of WEB, Cambro, their respective affiliates, subsidiaries, related entities, advertising and promotion agencies and suppliers, and the immediate family members or those individuals living in the same household of each are not eligible to enter or win. Void where prohibited or restricted by law. Subject to all applicable federal, state, and local laws and regulations.
  
- 3. Agreement to Rules:** Entrant agrees to be bound by these Official Rules and agrees to accept the decisions of Sponsors regarding the Sweepstakes and these Official Rules as final and binding, and Entrants may be disqualified for violations of these Official Rules.
  
- 4. Sweepstakes Entry Period:** Sweepstakes entry period begins on May 1, 2026, at 12:00:00 AM Eastern Time (“ET”) and ends on May 31, 2026 at 11:59:59 PM ET (the “Entry Period”). WEB’s computer clock is the official timekeeper for the Sweepstakes.
  
- 5. How to Enter:** There are two (2) methods of entry:
  - (1) Entrants must purchase at least one hundred dollars (\$100) of CAMBRO products listed on the official Sweepstakes page located at <https://www.webstaurantstore.com/feature/35990/cambro-2026-sweepstakes/> (“Sweepstakes Page”) during the Entry Period; or
  
  - (2) Send an email with your full name, Company name and address of the commercial establishment or space that contains the delivery station or walk-in to be made-over to WEB at [Cambrosweepstakes@webstaurantstore.com](mailto:Cambrosweepstakes@webstaurantstore.com) with the subject line “Enter Cambro 2026 Spring Clean Sweepstakes” during the Entry Period.

Limit one (1) Entry per company. Entrants and entries must fulfill all requirements to be eligible to win Prize. Entries that are not complete or do not adhere to the Official Rules may be disqualified at the sole discretion of Sponsors. Entrant may only submit one entry. Entrant may not use multiple email addresses, identities, or devices in an attempt to circumvent this rule. If Entrant uses fraudulent methods or otherwise attempt to circumvent the rules, their entry may be disqualified at the sole discretion of Sponsors.

**6. Prize:** One (1) Prize winner will receive the following:

- One (1) Cambro credit with a value of twenty-five thousand dollars (\$25,000) to use towards the purchase of CAMBRO products at the list price at <https://www.cambro.com/catalog/>. Winner can use the Cambro products to outfit, or as part of a makeover of its establishment. Prize includes products at their list price only, does not include installation or any construction or renovation costs to winner's commercial establishment or overall space. Products purchased with the credit will ship directly from Cambro to the winner.

The total ARV of the Sweepstakes is twenty-five thousand dollars (\$25,000). No cash value will be issued. Prize details are in Sponsors' sole discretion. Winners may not substitute, assign or transfer Prize, including but not limited to another business it owns or operates, but Sponsors reserve the right, at their sole discretion, to substitute Prizes (or portion thereof) with one of comparable or greater value. Winner will be issued an IRS 1099 tax form in the amount of the prize ARV. Payment of all Prize-related costs and expenses, including, without limitation, any and all federal, state, and/or local taxes, shall be the sole responsibility of winner. Acceptance of a Prize constitutes winner's permission for Sponsors to use winner's name, likeness, and entry for advertising, marketing, and trade use without further compensation, unless where prohibited by law.

**7. Odds:** The odds of winning depend on the number of eligible entries received.

**8. Winner Selection and Notification:** The winner of the Sweepstakes will be selected in a random drawing by Sponsor. The winner will be notified via email to the email address submitted in the entry to the Sweepstakes, within seven (7) days following winner selection. Sponsors shall have no liability for a winner's failure to receive email notices due to spam, junk email, or other security settings or for a winner's provision of incorrect or otherwise non-functioning contact information. Each potential winner will be required to complete and return an Affidavit of Eligibility, IRS W9 form, and Release of Liability/Publicity within fourteen (14) days of date of Prize notification. If such documents are not returned with the specified time period, Prize notification is returned as undeliverable, or the selected winner cannot be contacted or is ineligible, the Prize shall be forfeited, and an alternate winner may be selected in a random drawing from among all remaining eligible entries.

**9. Rights Granted by Entrant:** Entrant understands that Sponsors, anyone acting on behalf of Sponsors, or their respective licensees, successors, and assigns will have the right, where permitted by law, without any further notice, review, or consent by Entrant to print, publish, broadcast, distribute, and use, worldwide, in any media, now known or hereafter in perpetuity and throughout the world, Entrant's entry, including, without limitation, the Entrant's name, portrait, picture, voice, likeness, image, or statements about the Sweepstakes, and biographical information, as news, publicity, or information and for trade, advertising, public relations, and promotional purposes without any further compensation. Entrant further agrees and authorizes Sponsors to film and photo the original and new space, including during installation, up to a one-day video and photo shoot, featuring the made-over space and new CAMBRO products in use, scheduled at a time convenient to winner. All efforts will be made to not interfere with normal operations of winner's commercial establishment. Video and photos may be posted to [www.youtube.com/iamcambro](http://www.youtube.com/iamcambro), [www.cambro.com](http://www.cambro.com), [www.webstaurantstore.com](http://www.webstaurantstore.com), or any current and future social media channels. Any employees of winner appearing in videos or photos will be required to sign a Release of Liability/Publicity.

**10. Terms:** Sponsors reserve the right, in their sole discretion, to cancel, terminate, modify, or suspend the Sweepstakes should a virus, bug, non-authorized human intervention, fraud, or other cause beyond its control corrupt or affect the administration, security, fairness, or proper conduct of the Sweepstakes. In such case, Sponsors may select each winner from all eligible entries received prior to and/or after (if appropriate) such intervening event. Sponsors have the sole discretion to disqualify any Entrant who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or any website associated with the Sweepstakes or violates the Official Rules. Sponsors, in their sole discretion, shall maintain the integrity of the Sweepstakes, and may void entries for any reason, including, but not limited to, multiple entries from the same Entrant; multiple entries from the same computer in violation of the Official Rules; or the use of bots, macros, scripts, or other technical means for participation. Any attempt by an Entrant to deliberately damage any website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil laws. Should such an attempt be made, Sponsors reserve the right to seek damages from any such Entrant to the fullest extent permitted by law.

**11. Limitation of Liability:** Entrant agrees to release and hold harmless WEB, Cambro, and their subsidiaries, affiliates, related companies (including but not limited to Clark Core Services, LLC, and The Restaurant Store, LLC), advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) Entrant's participation in the Sweepstakes and/or their acceptance, possession, use, or misuse of any Prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware, or software; (iii) the unavailability or inaccessibility of any transmissions or telephone or internet service; (iv) unauthorized human intervention in any part of the entry process or the Sweepstakes; or (v) electronic or human error which may occur in the administration of the Sweepstakes or the processing of entries.

**12. Disputes:** As a condition of participation, Entrant agrees any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes will be resolved individually, without resort to any form of class action, and exclusively before a Pennsylvania court having jurisdiction. Entrant agrees Pennsylvania law will apply to any dispute, claims, and causes of action, regardless of conflict of law doctrines. Entrant waives all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than Entrant's actual out-of-pocket expenses (*i.e.*, costs associated with entering the Sweepstakes). Entrant waives all rights to have damages multiplied or increased.
