Installs directly under fountain or other application, or may be located in service area to serve up to 2 remote outlets (within 15 feet recommended). Unit shall be certified to UL 399 and CAN/CSA C22.2 No. 120. Unit shall be lead-free design which is certified to NSF/ANSI 372 (lead free) and meets Federal and State low-lead requirements.

- Cooling Unit: Combination tube-tank type. Continuous copper tubing is fully insulated with foam that meets UL requirements for self-extinguishing material.
- Refrigerant Control: Refrigerant R134a is controlled by accurately calibrated capillary tube.
- Temperature Control: Easily accessible enclosed adjustable thermostat is factory preset. Requires no adjustment other than for altitude requirements.

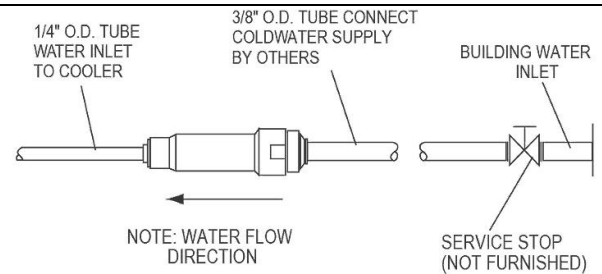

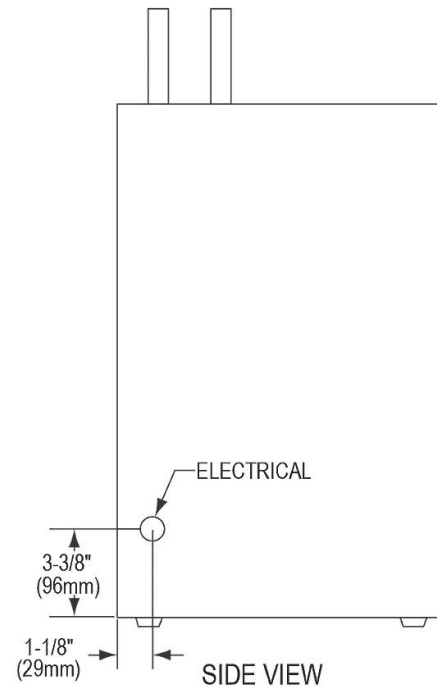
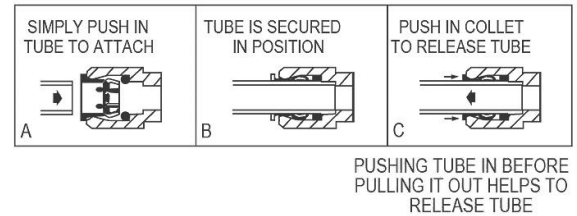
TOP VIEW

NOTE: When mounting unit in an open area, to ensure proper ventilation, maintain a 4" (102mm) clearance from cabinet louvers on each side of chiller. When mounting unit in a cavity or behind a wall, maintain minimum space of 4" (102mm) on each side, 4" (102mm) on the top and a depth of 12" (305mm).
