Disassembling and reassembling the compact dustpan for cleaning is easy. To remove the lid from the pan's base, simply rotate the lid to a 45-degree angle, then gently pull on the side hinges. Once disassembled, it can be cleaned in an industrial dishwasher or by hand.

The rounded lip and slight flexibility make it easy to sweep up fine particles or large debris. The pan holds around 1 gallon, making it useful for retail and industrial applications. Thanks to the dustpan's lid shape, you can store it upright with a broom tucked inside.
